## Nat Turner's Rebellion, Abolitionists, Judgment, and the End of Abortion

In 1829, Before Nat Turner's rebellion, David Walker -- a free black man who lived in Boston -- wrote "An Appeal." In it he prophesied the coming of the Civil War, and urged blacks to revolt against their masters.

"In fact, they are so happy to keep in ignorance and degradation, and to receive the homage and the labour of the slaves, they forget that God rules in the armies of heaven and among the inhabitants of the earth, having his ears continually open to the cries, tears and groans of his oppressed people; and being a just and holy Being will at one day appear fully in behalf of the oppressed, and arrest the progress of the avaricious oppressors; for although the destruction of the oppressors God may not effect by the oppressed, yet the Lord our God will bring other destructions upon them--for not unfrequently will he cause them to rise up one against another, to be split and divided, and to oppress each other, and sometimes to open hostilities with sword in hand... Will he let the oppressors rest comfortably and happy always? Will he not cause the very children of the oppressors to rise up against them, and oftimes put them to death? "God works in many ways his wonders to perform."

Abolitionists referred to slavery as: "a crime against God and man," "man stealing," "kidnapping," "sin," and that "the blood of 1 million brothers cried to God for vengeance."

The abolitionists railed against the slaveholders with unceasing invective, declaring that the judgment of God come upon America because of this vile crime, thereby echoing the sentiments of Thomas Jefferson when he said: "I tremble for my country when I remember that God is just, and that his justice cannot sleep forever."

After Nat Turner's rebellion, the slaveholders insisted that it was the rhetoric of abolitionists that propelled Nat Turner to act.

After revolt, Garrison said: "We are horror struck..."

But he also condemned slavery as the "cauldron" from which Turner's insurrection overboiled.

"In his fury against the revolters, who will remember their [slaveholders] wrongs."

"The slaves need no incentives at our hands."

He spoke of "patriotic hypocrites" who deny black people the right to "rise to contend -- as other 'heroes' have contended -- for their lost rights."

The National Intelligencer: Garrison was the "...instigator of human butchery."

South Carolan Vigilance Association offered \$1,500 for Garrison; Georgia Legislature offered \$5,000 if brought to Georgia to stand trial for seditious libel.

Multiple legislators banned or tried to ban the paper at various levels.

As the months went on, Garrison's rhetoric was more fierce, not less. He said: "I hold my life at a cheap rate."

In the wake of the Nat Turner insurrection, the Virginia legislature --fueled in part by the rhetoric and demands of the abolitionists – began the debate for the ultimate emancipation of all slaves.

Thomas Jefferson's grandson – Thomas Jefferson Randolph – prophesied the coming of the Civil War if slavery was not removed from Virginia.

“Randolph foresaw ‘a dissolution of the Union.’ A northern ‘invasion... in part with black troops,’ would offer ‘arms and asylum’ to slaves. When white males ‘shall march to repel’ Yankees, ‘their families’ would be ‘butchered in their homes desolated in the rear.’”

After the war, President Lincoln confirmed that the prophetic warnings of David Walker, William Lloyd Garrison, Thomas Jefferson Randolph, and others had indeed come true: that the Civil War was the judgment of God.

Both read the same Bible and pray to the same God, and each invokes His aid against the other. It may seem strange that any men should dare to ask a just God's assistance in wringing their bread from the sweat of other men's faces, but let us judge not, that we be not judged. The prayers of both could not be answered. That of neither has been answered fully. The Almighty has His own purposes. "Woe unto the world because of offenses; for it must needs be that offenses come, but woe to that man by whom the offense cometh." If we shall suppose that American slavery is one of those offenses which, in the providence of God, must needs come, but which, having continued through His appointed time, He now wills to remove, and that He gives to both North and South this terrible war as the woe due to those by whom the offense came, shall we discern therein any departure from those divine attributes which the believers in a living God always ascribe to Him? Fondly do we hope, fervently do we pray, that this mighty scourge of war may speedily pass away. Yet, if God wills that it continue until all the wealth piled by the bondsman's two hundred and fifty years of unrequited toil shall be sunk, and until every drop of blood drawn with the lash shall be paid by another drawn with the sword, as was said three thousand years ago, so still it must be said "the judgments of the Lord are true and righteous altogether."

The moral of the story is this:

1. An evil has cursed the face of this nation which is far worse than slavery; namely, the murder of innocent children by abortion.
2. Child-killing is a cauldron of evil, from which violence and horror will spread.
3. Though our political enemies call us "domestic terrorists, the duty of pro-lifers is to condemn childkilling in the clearest, most strident terms possible.
4. Just as with Slavery, there is a God in Heaven – whose justice will not sleep forever – who will bring judgment on our land because of this crime.
5. It is the duty of every legislator in this nation to work to eradicate this evil from our land.
6. Every U.S Senator who fears God and loves life should filibuster Sotomayor, and every other judicial appointment that does not pledge to overturn Roe.
