

JOHN PAUL II TO AMERICAN BISHOPS:

“As Pastors, you must make every effort to ensure that there is no dulling of consciences regarding the seriousness of the crime of abortion—a crime which cannot be morally justified by any circumstance, purpose or law (cf. *Evangelium Vitae*, 62).(3)”

“An essential feature of support for the inalienable right to life, from conception to natural death, is the effort to provide legal protection for the unborn, the handicapped, the elderly, and those suffering from terminal illness. As Bishops, you must continue to draw attention to the relationship of the moral law to constitutional and positive law in your society: ‘Laws which legitimize the direct killing of innocent human beings are in complete opposition to the inviolable right to life proper to every individual; they thus deny the equality of everyone before the law’ (*Evangelium Vitae*, 72)... Democracy stands or falls with the values which it embodies and promotes (cf. *Evangelium Vitae*, 70). In defending life you are defending an original and vital part of the vision on which your country was built. America must become, again, a hospitable society, in which every unborn child and every handicapped or terminally ill person is cherished and enjoys the protection of the law. (6)” *John Paul II*

HERE ARE THE FACTS:

1 Sotomayor was appointed by arch child-killer President Obama. Can any thinking person believe that Obama would pick someone for the Supreme Court that did not share his commitment to kill children?

2 After she met with arch child-killer Senator Ron Wyden (D-Ore), he said: "I was very pleased that the judge [Sotomayor] indicated that in the past that she has had a great respect for precedent and that Roe v. Wade is established law..."

3 After meeting with arch child-killer Senator Diane Feinstein (D-Calif) Feinstein spoke of Roe v. Wade as a settled "precedent," and added: "I believe she has a real respect for precedent and . . . if that is really true then I will agree with her, and I believe it is." (This was code language for the pro-aborts to calm their fears.)

4 On the morning she was nominated by Obama, the child-killers at N.O.W. (Nat'l Organization of Women) leapt forward to sing her praises, saying: "This morning we will celebrate, and this afternoon NOW will launch our 'Confirm Her' campaign to ensure the swift confirmation of the next Supreme Court Justice." Can any thinking person believe that the N.O.W. would endorse someone unless they were 100% sure that the nominee would continue child-killing? The N.O.W. knows its mission.

5 Sotomayor was a governing board member of the Puerto Rican Legal Defense and Education Fund (PRLDEF) for 12 years (1980-1992). The PRLDEF filed "Friend of the Court" briefs with the Supreme Court in five child-killing cases. In their briefs, the PRLDEF argued that child-killing was a fundamental right. On May 28, the child-killing rag, the New York Times, reported: "The board [of the PRLDEF] monitored all litigation undertaken by the fund's lawyers, and a number of those lawyers said Ms. Sotomayor was an involved and ardent supporter of their various legal efforts." I.e., Sotomayor is a radical supporter of child-killing.

6 Senator Jim DeMint (R-SC) met with Sotomayor. He said: "When I asked if an unborn child has any rights whatsoever, I was surprised that she said she had never thought about it." NEVER THOUGHT ABOUT IT?!?! Who but a diehard supporter of killing babies would say – as a lawyer and a judge no less! – that she had "never thought about" the rights of unborn children?!

IF YOUR LIFE WAS THREATENED...

A Word about Catholic Bishops And Evangelical Ministers

During the scandal of Obama speaking at Notre Dame, 83 U.S. Catholic Bishops spoke publically against his appearance. That was very encouraging to the faithful.
